1. Background

The Education Advocacy Network (EAN) is a non-profit organization dedicated to promoting education as a fundamental right and eradicating child labour through community-driven interventions. Under the From Mines to School Project implemented in partnership with Resource Rights Africa, Oxfam and funded by the European Union, EAN is working in the Karamoja region of Uganda, specifically in the districts of Amudat, Nakapiripirit, and Moroto, to transition children from the worst forms hazardous work in artisanal mining to quality education.

The project aims to address systemic barriers such as poverty, inaccessibility to schools, and cultural practices that perpetuate child labour, with notable progress including a reduction in child labour in target districts.

To enhance access to education in remote and target sub-counties of Karamoja, EAN seeks a qualified service provider (individual or entity) to design, deliver, and equip 6 Mobile Learning Facilities tailored to the needs of children in mining communities. These facilities will serve as flexible, durable, and conducive learning environments, supporting the project's goal of ensuring inclusive and equitable education for all.

Objectives

The service provider will:

- Design and provide 6 mobile learning facilities equipped with ventilation and openings to ensure a comfortable and conducive learning environment.
- Brand the facilities attractively to reflect a child-friendly and education-focused aesthetic that promotes engagement.
- Fit the facilities with appropriate furniture for learners and teachers, ensuring functionality and comfort.
- Transport the mobile learning facilities to designated sub-counties in the districts of Amudat, Nakapiripirit, and Moroto.
- Provide a durability assurance of at least 36 months for all products and installations.
- Offer innovative contributions to enhance the mobile learning facility's functionality and impact.
