The supplier will undertake the following tasks Supply of Teaching and Learning Materials; Provide materials tailored to the AEP curriculum, including but not limited to learner and teacher materials: Text books, Notebooks, manila papers, Flip charts, mathematical sets, Exercise Book 48 page books, counter books, black board rulers, boxes of chalk, ruled paper, black board paint, sharpeners, pens, pencils, erasers, rulers, and exercise books suitable for primary level (ages 5–17).
